Admission in September 2024

1. Application period :

Date : 2/1/2024 (Tuesday) to 16/1/2024 (Tuesday)

Time : Monday to Friday: 9:00am – 12:30 pm, 2:30pm – 5:00 pm

Saturday: 9:00 am- 12:00nn

2. The application form can be obtained from 13 November 2023 (Monday) to 16 January 2024 (Tuesday). Applicants may obtain the form:

- ii. from school website (<https://www.shd.edu.hk/>)
(Admission→S1 Admission (2024-2025 DP) →Application Form for Admission to Secondary One)

3. Admission requirements

- i. Current P6 students from primary schools participating in Secondary School Places Allocation
- ii. Good academic performance
- iii. Good conduct

4. Application procedures

Applicant may choose one of the following methods to submit the application:

- A. in person or by an authorized person
- B. by post[#]
- C. via SSPA e-Platform⁺

The following documents should be returned to our General Office in person, by an authorized person or by post[#] to TWGHs Sun Hoi Directors' College, Wu King Estate, Tuen Mun.

- i. Completed 'Application Form for Admission to Secondary One' from the school
- ii. *Photocopy* of the HKID card *
- iii. *Photocopies* of school reports for P5 (First and Second Term) and P6 (First Term) *
- iv. *Photocopies* of certificates/awards of extra-curricular activities *
- v. *Original copy* of 'Application Form for Secondary One Discretionary Places' issued by EDB
- vi. An addressed envelope with sufficient postage for in-person submission (Two addressed envelopes with sufficient postage for postal submission)

Remarks:

【Recommendation letters from primary schools are not required.】

* For in-person submission, the original copies of ii,iii and iv should be produced for checking.

[#] For postal application, please specify on the envelope with 'Application for Secondary One Discretionary Places'. A registered email is recommended to avoid postal delay. Upon receipt of the application, the Parent's Copy will be returned to be the applicant for retention and record. An email of receipt will be sent to all applicants within 7 days if email address is provided in the application form.

5. Interview arrangements

- i. Interviews will be arranged for ALL applicants.
- ii. An invitation letter will be mailed to all applicants on or before 23 February 2024 (Friday).
- iii. The tentative date for the interview will be 9 March 2024 (Saturday).
- iv. Interviews will be conducted to BOTH parents and students in English and Cantonese.

8. Release of results

Our school will notify parents of successful applicants both by telephone and by mail on **27 March 2024 (Wednesday)**. These notification arrangements are not applicable to reserve and unsuccessful applicants, nor are the notifications the allocation results. Students will be notified of their allocation results on **9 July 2024 (Tuesday)**, the same time as those who are allocated Secondary One Places through Central Allocation. Please do not enquire about the allocation results before then.

Remarks: Less than 10% of places will be reserved for applicants who excel in Sports and Arts but fail to meet the general requirements.
